Additional panels may be available at \$5.00 each depending on space.) If you have personal racks to set up, there is a \$25.00 fee for space.

POSTMARK DEADLINE: Saturday, August 15th
Applications received AFTER THE DEADLINE WILL NOT BE ACCEPTED.

There will be a 20% commission on all sales. Sales tax will be the responsibility of participants. All sales will be handled at the cashiers' table. SMAL will forward a check to the artist, less the show commission and charge card fees (if applicable).

CONDITIONS AND RESTRICTIONS: You exhibit at your own risk. SMAL and its assigns are not responsible for accidents or damage to your works. Members exhibiting shall be available each day to help set up and disassemble the exhibits.

SPACE: The show coordinators will assign spaces for your work.

SET UP: Saturday morning September 5th 9 AM. Participating artists shall set up and break down their own displays, but may not break down before 5 PM on Sunday, September 6th.

OPERATIONS: The operation of the show is to be overseen by Chair Patsy Dautle and Pat Hanlon, and members of the committee. Phone and contact information is on the reverse side of this sheet. In the event of too large a response, acceptances will be given to the earliest postmarked paid returns.

Our location under the tent will oblige us to set up and take down all exhibits, paintings, tabletop items and displays each day. This will call for cooperation among all exhibitors to set up and dismantle our exhibits each day. This will mean that we (you) are responsible for this on both Saturday and Sunday afternoons (not before closing time, please.)

We welcome your participation and will work to make it as uncomplicated as possible. This will require you agree to the following:

1. Be present to assist in the set up and take down of original art exhibits and display materials each day we exhibit.
2. Be flexible in the event of rain to be at the display to remove your work and protect it against rain damage.
3. Assist in the general operation of the weekend show, including one hour assisting at the sales table, and marketing the event in advance.
4. Entries must be original works by the exhibiting artist. "Original" means never having occurred or existed before and invented or created solely by the exhibitor. No copies of art or photographs by other persons may be exhibited.
5. Computer modified art must be labeled as such.
6. Giclees and prints may only be offered for sale in bins.
